

# 8 Steps to Certification for Cellular Enabled IoT Devices

Deploying your Internet of Things (IoT) devices using cellular technology is easier than you think. Follow these eight simple steps to bring your IoT device to market quickly and cost-effectively.

#### 1 Design Around a Certified Module

Save time and cost by designing your device around a module certified for IoT applications. A large number of certified modules are available that offer a variety of features and functions for your specific needs.

## 2 Verify Network Operator Requirements

Consult with the network operators in your target markets to determine their individual requirements. Some may require additional operator-specific testing.

## Comply with Government Regulations

Ensure you will meet government regulations in your target markets. Our authorized test labs are experts and can assist with this. For example, in North America, wireless devices must comply with U.S. FCC and Canada ISED telecommunications rules.

## 4 Start the Certification Process

IoT Network Certified leverages the resources of the PTCRB certification program. Register at <u>certify.ptcrb.com</u> and request certification for your IoT device. Select the module you are using in your device from the drop-down list of certified modules.

## 5 Select a Test Lab

Select an authorized test lab from our list of qualified laboratories around the world. The lab will determine the testing appropriate for your device, conduct the testing, and upload the test results to the certification database.

## **6** Submit Required Documentation

Upload required documentation to the certification database.

#### Pay the Certification and Testing Fees

There is a flat certification fee payable to CTIA Certification. The testing fees are independently determined by each test lab. Once the fees are paid and all documents are submitted, your device will be certified.

## 3 Receive Certification

Once it has been verified that you've met all certification requirements, you will receive confirmation of certification via the certification database.
